ORDER

The appellant has preferred his 1st appeal through RTI portal bearing No. PODEP/A/2019/60035 dated 01.06.2019 against CPIO/Central in connection with his RTI application (bearing No. PODEP/R/2019/50333 dated 24.04.2019) with the contentions that requisite information was not supplied to him. The same was registered vide No. 107/UT/RTI/FAA/SSP dated 03.06.2019.

Information sought vide RTI application :

The appellant had sought information/documents on 4 points as under:1) Medical examination done by SI Balinder Singh of PS-22 of my son Aditya Arora and My daughter in law Prabhjot Kaur on 18.04.2019. 2) Copy of DDR filed against call to PCR on 18.04.2019. 3) Compromise between my son Aditya Arora and my daughter in law Prabhjot Kaur done on 18.04.2019. (4) Complaint filed by Prabhjot Kaur against Chander Mohan Arora, his wife Amita Rashmi and son Aditya Arora at PP-22 on 20.04.2019.

Comments of CPIO/Central:

CPIO/Central submitted that RTI application of the appellant was received through online RTI portal bearing No. PODEP/R/2019/50333 dated 24.04.2019. In this regard, requisite information was obtained from SHO/PS-17, thereafter point wise reply was supplied at online portal to the appellant as well as by post on 15.05.2019.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant had sought information on 4 points as under:-

1) Medical examination done by SI Balinder Singh of PS-22 of my son Aditya Arora and My daughter in law Prabhjot Kaur on 18.04.2019. 2) Copy of DDR filed against call to PCR on 18.04.2019. 3) Compromise between my son Aditya Arora and my daughter in law Prabhjot Kaur done on 18.04.2019. (4) Complain filed by Prabhjot Kaur against Chander Mohan Arora, his wife Amita Rashmi and son Aditya Arora at PP-22 on 20.04.2019.

In reply, CPIO/Central supplied the point wise reply to the appellant as per RTI Act.

So far as the appeal is concerned, from the thorough perusal of record in hand, it is clear that point wise information was supplied to the appellant by the CPIO/Central but appellant has contended in the appeal vide point No. 1 that complete medical report of his son Aditya Arora was not provided to him. Since, this information is third party information; therefore, CPIO/Central is hereby directed to supply the requisite information, if available, to the appellant after taking the consent of Aditya Arora as per section 11 of RTI Act.

Moreover, appellant had raised his grievance / queries in point No. 2 & 3 in the appeal regarding the information provided by the CPIO which is not covered under RTI Act, hence, no need to entertain the same in the appeal.

With these observations, the instant appeal is hereby disposed of accordingly

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
