ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 88/UT/RTI/FAA/SSP dated 26.08.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION :-

The appellant had sought information on five points pertaining to his case FIR No. 07/2020 PS-19 i.e. copies of complaints, certified copies entire office noting, correspondence along with orders and action taken report of his complaint bearing No. 202005275 etc.

COMMENTS OF CPIO/EAST :-

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office from CAPIO/PHQ vide letter no. 375/RTI/CAPIO/PHQ/UT/PWS dated 21.07.2020. Thereafter, requisite information was denied u/s 8(1)(h) of RTI Act as the case FIR No. 7/2020 u/s 3(1)(vi) & (x) of SC/ST (Prevention of Atrocity) Act 1989 of PS-19, Chandigarh which was/(is) under investigation.

DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on

five points pertaining to his case FIR No. 07/2020 PS-19 i.e. copies of complaints, certified copies entire office noting, correspondence along with orders and action taken report of his complaint bearing No. 202005275 etc.


In reply, CPIO/East had denied requisite information u/s 8(1)(h) of RTI Act.

So far as the appeal is concerned, it is clear that case FIR No. 7/2020 PS-19, Chandigarh is still under investigation, hence, CPIO/East had rightly denied the part information by applying section 8(1) (h) of RTI Act. However, as appellant is the accused in the said case, therefore, the copy of aforementioned FIR can be supplied.


Moreover, as the appellant's complaint bearing No. 2020-05275 is concerned, the same is consigned with HAC branch as per the record of public window system, therefore, the same can also be supplied.

In view of above, CPIO/East is hereby ordered to supply the copy aforementioned FIR and also supply the copy of action taken report of appellant's complaint bearing No. 2020-05275. With these directions, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
