### **ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application dated 11.05.2019, received on 17.05.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. R-116/UT/RTI/FAA/SSP dated 24.06.2019 for further proceeding under RTI Act.

# Information sought vide RTI application:

The appellant had sought information pertaining to complaint filed by the appellant on 11.04.2019 bearing PWS no. 2019-07182 dated 25.04.2019.

## Comments of CPIO/South:

CPIO/South submitted that online RTI application of the appellant was received from CAPIO/PHQ vide letter no. 1133/RTI/CAPIO/PHQ/UT/PWS dated 17.05.2019 for supplying information pertaining to complaint filed by the appellant on 11.04.2019 bearing PWS no. 2019-07182 dated 25.04.2019. Thereafter, requisite information was obtained from SHO PS Sector 31 who submitted that complaint no. 2019-07182 dated 25.04.2019 is under enquiry and as per record of PS, no telephonic complaint was received. Hence, requisite information was denied to the appellant u/s 8(1)(h) of RTI act.

#### Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information pertaining to complaint filed by the appellant on 11.04.2019 bearing PWS no. 2019-07182 dated 25.04.2019.

In reply, CPIO/South had informed the appellant that complaint filed the appellant on 11.04.2019 bearing PWS no. 2019-07182 dated 25.04.2019 is under enquiry, Hence, requisite information with respect to above said complaint was denied to the appellant u/s 8(1)(h) of RTI act and with respect to point no. 02, appellant was informed that as per record of PS, no telephonic complaint was received.

So far as the appeal is concerned, the complaint in question is still under enquiry, hence, requisite information cannot be supplied at this stage. The same can only be supplied after completion of enquiry in the complaint. Moreover, with respect to point no. 02, CPIO submitted that as per record of Police Station Sector 31, no telephonic complaint was received.

Keeping in view the fact that appellant is complainant in the complaint, CPIO/South is hereby directed to cooperate with him and apprise him about the progress of the complaint as and when appellant approaches his office. No more action is required to the taken on the instant appeal at this stage, the same is hereby disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
