

**THE SUPERINTENDENT OF POLICE, HQs.-CUM-APPELLATE
AUTHORITY, COMMUNICATION, UNDER RIGHT TO INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the First Appeal dated 14.05.2021, preferred by Sh. Sukhwant Singh R/o 113, Dhanas, Chandigarh under RTI Act 2005, received in this office on 03.06.2021, through SSP/UT-cum- First Appellate Authority, against the disposal of his RTI Application dated 26.02.2021.

(2) The appellant, vide his RTI application bearing no. jsc23/2021/26 dated 17.02.2021 under RTI Act 2005, had requested, CAPIO/PHQ to supply him some information in 03 points pertaining to a call made by 9915138266 on 100 number and the action taken on the call. In-charge, Public Window (PHQ)-cum-CAPIO, PHQ, vide No. 198/RTI/CAPIO(PHQ)/UT/PWS dated 26.02.2021, transferred the RTI application to CPIO/Communication for its disposal. On perusal of RTI application CPIO/Communication found that only point no. 01 is related to Communication wing. Therefore, point no. 2 & 3 were transferred to Sh. Krishan Kumar, DSP-cum-CPIO/Central for disposal at his own level. CPIO/Communication disposed-of the RTI application, vide No. RTI-22/DSP/Comm./ UT dated 04.03.2021.

(3) The appellant, not satisfied with the manner in which his application was disposed of, has filed the instant appeal.

(4) The comments of DSP-cum-CPIO/Communication have been called for. He has reported that Sh. Sukhwant Singh R/o H NO. 13, Dhanas, Chandigarh has filled this appeal, for not supplying him required information within stipulated period in regard to his RTI request by CPIOs. Whereas, in regard to this wing, the factual position of this case is as under:-

A RTI request of the applicant was transferred to this office by CAPIO/PHQ/PWS vide No. 198/RTI/CAPIO(PHQ) dated 26.02.2021.

The requisite information of Point No. 1 i.e. CD-1 & page-01 (recording of 112 No. call and details of incident of dated 11.02.2021) was obtained from the inspector/communication (Admn.) and was supplied to the applicant while disposing of his request vide this office No. RTI-22/DSP/Comm. dated 04.03.2021 which received by the applicant by visiting this office on dated 10.03.2021. The required information has already been supplied to the applicant within stipulated period by this wing.

So far as concern of Point No. 2 & 3 of RTI Application, the matter was pertain to CPIO/Central and RTI application was transferred to the CPIO/Central vide No. D-59-60/DSP/Comm. dated 12.03.2021 for disposal of Point No. 2 & 3.


The information so available with this Wing has already been provided to the applicant and he is satisfied with the reply.

(5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Communication. The appellant, through RTI application, had sought information on 03 points relating to a call made by 9915138266 (applicant mobile) on 100 no at 3.31 PM dated 11.02.2021. However, only point number 1 was related to CPIO/Communication. The information sought by the applicant, supplied by

the CPIO, grievances raised by the appellant in RTI appeal and the order/decision of the undersigned, being first appellate authority w.r.t. CPIO/Communication only, is given below:

Point No. 01 Kindly provide me CD of call recording made by 9915138266 (applicant mobile) on 100 no at 3.31 PM dated 11.02.2021.	Point No. 01 So far as concern of information, only point no. 01, relates with Communication Wing, the information desired in your application, containing 01 page and CD-01, as supplied by Insp. Communication (Admn.), So you are requested to collect the same.	Sir, I got the CD requested by me against the payment of Rs. 52, which was supplied to me by the CPIO/Communication within stipulated period of the RTI. I was told that the further information on point no. 02 & 03, would be provided to me by the Police Station 03, Chandigarh. I went several times to PS-03 where they told me that the sought information would be provided to me by PS-17. On 03.05.2021, I received the reply from PS-17, Chandigarh. I want to know the reason for the delay in reply by the CPIO and the fine may please be imposed. Action to be taken against CPIO as per Law, please.	I have gone through all the relevant documents and found that the appellant does not have any issue with the disposal or supply of information on point no. 1 of his RTI application by CPIO/Communication and the appellant himself stated that he got the CD within stipulated period.
Point No. 02 Kindly provide me the copy of the pages which were signed by me.	The information on point No. 02 & 03 pertains to CPIO/ Central office.		However, it seems that he is not satisfied over the way his information supplied by CPIO/ Central and seeking justification for the delay in RTI reply. SSP/UT is appellate authority w.r.t. CPIO/Central and the appeal w.r.t. point no 02 & 03 will be decided by SSP/UT.
Point No. 03 Sir, if any other action has been taken on 11.2.2021, all those actions should be given to me.			
			The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
