ORDER

The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00069 dated 18.09.2020) against the reply of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/20/00356 dated 16.08.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 97/UT/RTI/FAA/SSP dated 18.09.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought copy of supplementary charge-sheet in case FIR No. 378 dated 17.10.2018, PS-34 and copy of charge-sheet of case FIR no. 180 dated 09.05.2018, PS -34.

COMMENTS OF CPIO/SOUTH:

CPIO/South submitted that RTI application of the appellant was received through online portal for supplying the requisite information. Accordingly point-wise reply was sent to the applicant vide No. 317/CPIO/South dated 14.09.2020.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copy of supplementary charge-sheet in case FIR No. 378 dated 17.10.2018, PS-34 and copy of charge-sheet of case FIR No. 180 dated 09.05.2018, PS-34.

In reply, CPIO/South had not supplied any documents/information instead he informed the appellant about the status of aforementioned case FIRs.

It is also pertinent to mention here that appellant is accused in case FIR No. 378/2018 and the same is under trial in the Ld. Court and the supplementary charge-sheet has already been presented in the Ld. Court. Therefore, appellant is advised to obtain the same from the Ld. Court.

Further, case FIR No. 180/2018 is still under trial in the Ld. Court, therefore, copy of charge-sheet of this case cannot be supplied to him as by disclosing the same, the proceedings of trial of the case may hamper. Hence, the same is denied u/s 8(1)(h) of RTI Act.

With the above observations, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
