ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/South & Hqrs in connection with his RTI application dated 07.05.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. R-113/UT/RTI/FAA/SSP dated 17.06.2019 for further proceeding under RTI Act.

Information sought vide RTI application :

The appellant had sought information on five (05) points pertaining to complaints dated 26.02.2019 of the appellant bearing PWS nos. 2019-03577 dated 01.03.2019 and 2019-03853 dated 06.03.2019.

Comments of CPIO/South :

CPIO/South submitted that RTI application of the appellant was received in his office through Indian Post on 13.05.2019 for seeking information pertaining to complaints bearing PWS nos. 2019-03577 dated 01.03.2019 and 2019-03853 dated 06.03.2019. Thereafter, requisite information was obtained from SHO PS Sector 36 who submitted that both the complaints were received in PS Sector 36 on 09.03.2019 and 18.04.2019 respectively and the same were sent to senior officers on 08.05.2019 after completion of enquiries. Hence, RTI application was transferred to CPIO/Hqrs and the appellant was informed accordingly vide letter no. 262/CPIO/South dated 18.05.2019. As far as the appeal is concerned, CPIO/South submitted that point wise reply has been supplied to the appellant and no information is pending at his disposal.

Comments of CPIO/Hqrs :

CPIO/Hqrs submitted that RTI application was received in his office from CPIO/South on 18.05.2019. Thereafter, I/C HAC was directed to supply the relevant complaint files bearing PWS nos. 2019-03577 and 2019-03853. After obtaining the relevant complaint files, appellant was requested to collect the requisite information from the office of CPIO/Hqrs. On 20.06.2019, Sh. Jagjit Singh (authorised person on behalf of the appellant) visited the office of CPIO/Hqrs and received the requisite information (consisting of 30 pages) vide letter no. 834/DSP/Hqrs/RTI dated 20.06.2019.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South & Hqrs vis-à-vis material available on record which revealed that the

appellant had sought information on five (05) points pertaining to complaints dated 26.02.2019 of the appellant bearing PWS nos. 2019-03577 dated 01.03.2019 and 2019-03853 dated 06.03.2019.

In reply, CPIO/South had informed the appellant that complaints dated 26.02.2019 bearing PWS nos. 2019-03577 dated 01.03.2019 and 2019-03853 dated 06.03.2019 were sent to Senior Officers after completion of enquiries. RTI application was also transferred to CPIO/Hqrs for further necessary action.

CPIO/Hqrs submitted that after obtaining the relevant complaint files, appellant was requested to collect the requisite information from his office. On 20.06.2019, Sh. Jagjit Singh (authorised person on behalf of the appellant) visited the office of CPIO/Hqrs and received the requisite information (consisting of 30 pages).

So far as the appeal is concerned, the requisite information (consisting of 30 pages) has already been received by the representative of the appellant from the office of CPIO/Hqrs. Hence, no more action is required to be taken on the instant appeal, the same is hereby disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
