ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/East in connection with his RTI application (bearing No. PODEP/R/E/20/00315 dated 06.09.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 101/UT/RTI/FAA/SSP dated 23.09.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought information on 11 points regarding complaints submitted by him in PS-26 in October, 2016 and other complaints against Shivam, Sunita, Jyoti and Manisha from 2016 to till date etc.

COMMENTS OF CPIO/EAST:

CPIO/East submitted that RTI application of the appellant was received through online portal for supplying the requisite information relating to his office. Accordingly, requisite information mentioned on front/covering page of online RTI application has been supplied to the appellant but in advertently attachment has been left without consideration. Moreover, similar applications received in his office on 14.09.2020, 21.09.2020 & 22-09-2020 and requisite information was supplied to the appellant vide letter No. 285& 286/RTI/CPIO/East dated 29.09.2020.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 11 points regarding complaints submitted by him in PS-26 in October, 2016 and other complaints against Shivam, Sunita, Jyoti and Manisha from 2016 to till date etc.

Initially, CPIO/East has supplied the part information on the basis of covering page of RTI Application, later on after receipt of similar RTI applications; he supplied complete information on all points.

Moreover, CPIO had denied for entertaining the grievances of the appellant mentioned in point No. 1 by applying section 2(f) of RTI act. Hence, no more action is required to be taken in the instant appeal and the same is hereby filed, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
