ORDER

The appellant has preferred her 1st appeal on 20.01.2020 against the reply/order of CPIO/South in connection with her RTI application dated 04.12.2019 with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide no. 05/UT/RTI/FAA/SSP dated 20.01.2020 for further proceeding under RTI Act.

Information sought vide RTI application : -

The appellant had sought the information on five (05) points pertaining to complaints bearing nos. 2019-06155 dated 10.04.2019 & 2019-19102 dated 04.10.2019, DDR Nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 etc.

Comments of CPIO/South :-

CPIO/South reported that RTI application was received in her office from CAPIO/PHQ vide letter no. 2378/RTI/CAPIO/PHQ/UT/PWS dated 06.12.2019 for seeking information pertaining to complaints bearing nos. 2019-06155 dated 10.04.2019 & 2019-19102 dated 04.10.2019, DDR Nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 etc. Thereafter, requisite information was obtained from SHO PS Sector 36, Chandigarh and the same was scrutinized thoroughly. After scrutiny, point-wise reply was supplied to the appellant vide letter no. 793/RTI/CPIO/South dated 23.12.2019 with the comments that the complaints bearing nos. 2019-06155 & 2019-19102 as well as DDR Nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 are under enquiry. Hence, action taken report cannot be supplied to the appellant.


Decision :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on five (05) points pertaining to complaints bearing nos. 2019-06155 dated 10.04.2019 & 2019-19102 dated 04.10.2019, DDR Nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 etc.

In reply, CPIO/South had denied the requisite information to the appellant as the complaints bearing nos. 2019-06155 & 2019-19102 as well as DDR Nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 were under enquiry at that time.

So far as the appeal is concerned, the complaint in questions are still under enquiry. Hence, final enquiry reports cannot be supplied at this stage also. However, copies of complaints bearing nos. 2019-06155 & 2019-19102, statements of complainant/appellant as well as copies of DDR nos. 63 dated 13.02.2019 & 65 dated 14.02.2019 can be supplied to the appellant. Accordingly, CPIO/South is hereby directed to supply the copies of aforementioned complaints, statement and DDR entries as per RTI act. He is further directed to cooperate with the appellant, being complainant in the aforesaid complaints, if she approaches and apprise her about the progress in the matter. With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
