### ORDER

The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00074 dated 28.09.2020) against the reply of CPIO/East in connection with his RTI application (bearing No. PODEP/R/E/20/00387 dated 27.08.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 105/UT/RTI/FAA/SSP dated 28.09.2020 for further proceeding under RTI Act.

## INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought information on 5 points pertaining to his complaint forwarded by Mewar Investor Welfare Forum vide No. GOCVV/E/2020/00452 dated 18 Aug. 2020 i.e. whether company is running the business, what is present position of company, complaints registered against company in last 15 years and mobile no. & email address of SHO etc.

## COMMENTS OF CPIO/EAST:

CPIO/East submitted that RTI application of the appellant was received through online portal for supplying the requisite information. Thereafter, report from SHO/MM was obtained who reported that complaint in question i.e. GOCVV/E/2020/00452 dated 18 Aug. 2020 has not been found received in the Police Station Manimajra, Chandigarh. Further, no such company is found running in the Jurisdiction of PS-MM and mobile No. & email address of SHO/MM has been provided to the appellant.

#### DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 5 points pertaining to his complaint forwarded by Mewar Investor Welfare Forum vide No. GOCVV/E/2020/00452 dated 18 Aug. 2020 i.e. whether company is running the business, what is present position of company, complaints registered against company in last 15 years and mobile no. & email address of SHO etc.

CPIO/East had informed the mobile number & email address of SHO/MM and also informed that no complaint of appellant has received in PS-MM.

So far as the appeal is concerned, CPIO/East has reported that no such complaint is received in Police Station Manimajra, Chandigarh. Moreover, appellant is raising his grievances pertaining to his so called complaint i.e. what is present status of company, whether the company is running or closed the business etc. which are not under the purview of RTI act.

In view of above, it is clear that no information is available in the record of PS Manimajra, hence the same cannot be supplied to the appellant. No more action is required to be taken in the instant appeal, the same is hereby filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
