**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 125/UT/RTI/FAA/SSP dated 01.07.2019 for further proceeding under RTI Act.

**Information sought vide RTI application :**

The appellant had sought copies of action taken report on complaint No. 2018-03970 dated 14.03.2018.

**Comments of CPIO/South :**

CPIO/South submitted that RTI application of the appellant was received from CAPIO/PHQ vide letter no. 1329/RTI/CAPIO/PHQ/UT/PWS dated 14.06.2019 for supplying requisite information. After obtaining the report from SHO/PS Sector 34, the requisite information was denied u/s 8(1) (h) of RTI Act as the complaint No. 2018-03970 was under enquiry at that time. Accordingly, the appellant was informed in this regard vide letter No. 351/CPIO/South dated 20.06.2019.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought copies of action taken report on complaint No. 2018-03970 dated 13.03.2018.

In reply, CPIO/South denied the requisite information u/s 8(1)(h) of RTI Act as the complaint in question was under enquiry at that time.

So far as the appeal is concerned, complaint in question i.e. 2018-03970 is still under enquiry, therefore, requisite information cannot be supplied at this stage. Hence, CPIO/South had rightly disposed of RTI application by applying section 8(1)(h) of RTI Act.

However, considering the fact that appellant is the complainant in aforementioned complaint, therefore, CPIO/South is hereby directed to cooperate with him and verbally apprise the progress/status of his complaint.

With these observations, the instant appeal is disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
