**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 129/UT/RTI/FAA/SSP dated 02.07.2019 for further proceeding under RTI Act.

**Information sought vide RTI application :**

The appellant had sought information on two points with regard to enquiry lodged vide DDR No. 56 dated 12.03.2019, PP-22, Chandigarh i.e. MLR report of Mrs. Parveen Mongia and letter written to PGI authorities by police and replies thereof.

**Comments of CPIO/Central:**

CPIO/Central submitted that RTI application of the appellant was received for supplying requisite information. After obtaining the requisite information from SHO/PS Sector 17, point wise information was supplied i.e. copies of MLR report and letter to PGI and its replies vide letter No. 240/CPIO/Central dated 11.06.2019. As far as appeal is concerned, no information is left out for supplying to the appellant.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant had sought information on two points with regard to enquiry lodged vide DDR No. 56 dated 12.03.2019, PP-22, Chandigarh i.e. MLR report of Mrs. Parveen Mongia and letter written to PGI authorities by police and replies thereof.

In reply, CPIO/Central had supplied the point wise information to the appellant.

So far as the appeal is concerned, CPIO has asserted that requisite information was supplied to the appellant by post. However, on the other side, appellant has claimed in his appeal that no information was received by him. Hence, CPIO/Central is hereby directed to provide the requisite information once again to the appellant as per RTI Act.

With these observations, the instant appeal stands dispose of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
