**ORDER**

\*\*\*\*\*

The appellant has preferred her 1<sup>st</sup> appeal against the reply/order of CPIO/East in connection with her RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 115/UT/RTI/FAA/SSP dated 15.10.2020 for further proceedings under RTI Act.

**Information sought vide RTI application :-**

The appellant had sought information pertaining to her complaint(bearing no. 2020-01374 dated 21.01.2020) submitted in PS Industrial Area, Chandigarh.

**Comments of CPIO/East :-**

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received directly in his office on 25.09.2020 for seeking information pertaining to her complaint filed in PS Ind. Area, Chandigarh. Thereafter, requisite information was obtained from SHO PS Ind. Area, Chandigarh who submitted that complaint in question was enquired and after completion of enquiry, enquiry report alongwith all relevant documents was sent to SDM/East on 14.08.2020. Hence, RTI application was transferred to CPIO of office of SDM/East, Chandigarh u/s 6(3) of RTI act. The appellant was informed accordingly vide letter no. 287/RTI/CPIO/East dated 02.10.2020.

**Decision :-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information pertaining to her complaint (bearing no. 2020-01374 dated 21.01.2020) submitted in PS Industrial Area, Chandigarh.


In reply, CPIO/East informed the appellant that complaint in question was enquired and after completion of enquiry, enquiry report alongwith all relevant documents, was sent to SDM/East on 14.08.2020. Accordingly, RTI application was also transferred to CPIO of office of SDM/East, Chandigarh u/s 6(3) of RTI act.

In view of above, instant appeal is being transferred to First Appellate Authority (FAA)-cum-Deputy Commissioner, Chandigarh, being FAA of SDM/East, Chandigarh.

So far as the appeal is concerned, considering the fact that appellant is complainant of complaint in question, copy of her statement can be supplied to her.

Henceforth, CPIO/East is hereby directed to thoroughly inspect the relevant record and if available, supply the copy of statement of the appellant/complainant to her as per RTI act. With these observations, the instant appeal is hereby disposed off as far as the office of the undersigned is concerned. For more information, the appellant is advised to contact the office of SDM/East, Chandigarh.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
