**ORDER**

The appellant has preferred his online 1<sup>st</sup> appeal vide registration no. PODEP/A/2019/60044 dated 05.07.2019 against the reply/order of CPIO/Hqrs in connection with his online RTI application bearing registration no. PODEP/R/2019/50430 dated 07.06.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 133/UT/RTI/FAA/SSP dated 05.07.2019 for further proceeding under RTI Act.

**Information sought vide RTI application :**

The appellant had sought information on 03 points regarding the reference bearing no. C-563/19/1786/UT/HAC dated 20.03.2019 sent to the National Commission for Women, New Delhi, complaint dated 17.10.2018 filed by the appellant against Rajan Singla & his parents and the action taken report on the directions of Family Welfare Committee on the complaints filed by the appellant against Rajan Singla & his parents etc.

**Comments of CPIO/Hqrs :**

CPIO/Hqrs submitted that online RTI application of the appellant was received in his office vide registration no. PODEP/R/2019/50430 dated 07.06.2019 through online RTI portal. Thereafter, contents of the RTI application were perused thoroughly which revealed that the information sought for, is related to the reference no. C-563/19/1786/UT/HAC dated 20.03.2019 sent to the National Commission for Women, New Delhi and the complaints bearing PWS nos. 2018-06646, 2018-07718, 2018-07725, 2018-09138, 2018-09164 & 2018-17573 which were consigned to record in HAC branch. On perusal of more relevant record it also came to light that the appellant and his wife Ms. Anita Garg had visited the office of CPIO/Hqrs on 04.06.2019 and received the information in the shape of 237 pages vide letter no. 249/DSP/Hqrs/Online/RTI-19 dated 04.06.2019. Thereafter, on 28.06.2019, they

further visited the office of CPIO and received the information in the shape of 115 pages vide letter no. 279/DSP/Hqrs/Online/RTI-19 dated 28.06.2019 after thorough inspection of the relevant files. The appellant was informed vide letter no. 271/DSP/Hqrs/Online/RTI-19/D-327 dated 05.07.2019 that he has already received the available information.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant had sought information on 03 points regarding the reference bearing no. C-563/19/1786/UT/HAC dated 20.03.2019 sent to the National Commission for Women, New Delhi, complaint dated 17.10.2018 filed by the appellant against Rajan Singla & his parents and the action taken report on the directions of Family Welfare Committee on the complaints filed by the appellant against Rajan Singla & his parents etc.

In reply, CPIO/Hqrs had informed that the appellant had already received the available information on two occasions in the shape of 237 pages and 115 pages after thorough inspection of relevant files.

So far as the appeal is concerned, the appellant is raising his grievances about the documents which according to his speculation/thought, should be present in the files whereas it is evident that the appellant has visited the office of CPIO/Hqrs with his wife on two occasions and received the requisite information in the shape of 237 pages and 115 pages after thorough inspection of the relevant files which showed that he has received the available information in the record. His grievances cannot be redressed under RTI act.

In view of above, appeal of the appellant stands filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
