### ORDER

The appellant has preferred his online 1st appeal (bearing registration No. PODEP/A/E/20/00080 dated 19.10.2020) against the reply of CPIO/South in connection with his RTI application (bearing registration No. PODEP/R/E/20/00477 dated 01.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 119/UT/RTI/FAA/SSP dated 19.10.2020 for further proceeding under RTI Act.

# INFORMATION SOUGHT VIDE RTI APPLICATION:-

The appellant had sought information pertaining to his complaint bearing No. 2020-15673 dated 03.10.2020 i.e. status of complaint, what action has been taken and detail of first appellate authority.

## COMMENTS OF CPIO/SOUTH:-

Comments of CPIO/South have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal for supplying the requisite information. Thereafter, requisite information was obtained from SHO PS Sector 31 who reported that complaint No. 2020-15673 dated 21.08.2020 was under enquiry. Accordingly requisite information on point no. 1 & 2 were denied by applying

section 8 (1) (h) of RTI act at that time. Moreover, point No. 3 i.e. name of first appellate authority has been provided to him vide letter No. 408/CPIO/South/dated 14.10.2020. As of now, said complaint is still under enquiry.

#### DECISION:-

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant has sought information pertaining to his complaint bearing No. 2020-15673 dated 03.10.2020 i.e. status of complaint, what action has been taken and detail of first appellate authority.

So far as the appeal is concerned, it is clear that complaint in question i.e. bearing No. 2020-15673 is still under enquiry. Moreover, appellant is complainant in this complaint and he wants to know about the status of his complaint as well as action taken report on the same. Hence, CPIO/South is hereby directed to cooperate with the appellant and apprise him about the current status of his complaint. With these directions, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
