ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/W&CSU in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 118/UT/RTI/FAA/SSP dated 19.10.2020. Thereafter, another appeal on similar matter was received against CPIO/South which was diarized vide No. 130/UT/RTI/FAA/SSP dated 17.11.2020 and both appeals were clubbed for further proceeding under RTI Act

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought information on four points regarding total cases along with its details registered from 01.01.2017 to till date, against women & children under IPC, IT Act, POCSO & Immoral Traffic Act.

COMMENTS OF CPIO/SOUTH:

CPIO/South submitted that RTI application of the appellant was received from CAPIO/PHQ vide no. 775/RTI/CAPIO/PWS/PHQ

dated 05.10.2020 for supplying the requisite information. Thereafter, reports from all SHOs of South Sub Division were obtained. Thereafter, point wise partial information i.e. detail of total cases were supplied to the appellant vide letter No. 412/CPIO/South dated 01.11.2020. However, detail of FIRs under IPC, POCSO Act & Immoral Traffic Act etc were denied under section 8(1j) of RTI Act being a third party.

COMMENTS OF CPIO/W&CSU :

CPIO/W&CSU submitted that RTI application of the appellant was received from CAPIO/PHQ vide no. 775/RTI/CAPIO/PWS/PHQ dated 05.10.2020 for supplying the requisite information. In this regard, appellant has informed that Women Police Station deals only matrimonial dispute cases of married couples.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South & W&CSU vis-à-vis material available on record which revealed that appellant had sought information on four points regarding total cases along with its details registered from 01.01.2017 to till date, against women & children under IPC, IT Act, POCSO & Immoral Traffic Act.

So far as the appeal is concerned, on careful going through the contents of RTI application, it revealed that appellant has sought information relating to crime against women & children under IPC, IT Act, POCSO & Immoral Traffic Act which contains personal information of complainants/victims of the respective case FIRs which cannot be supplied under section 8(1) (j) of RTI Act being third party personal information. Therefore, CPIO/South had rightly denied the requisite information; however, CPIO had rightly supplied police station wise total figures of cases.

As far as CPIO/W&CSU is concerned, he already informed the appellant that Women Police Station deals only cases related to matrimonial dispute.

In view of above, no more action is required to be taken in the both the appeals, hence, disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
