ORDER

The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00002 dated 30.01.2020) against the reply/order of CPIO/Central in connection with his RTI application (bearing No. PODEP/R/E/20/00020 dated 17.01.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 09/UT/RTI/FAA/SSP dated 30.01.2020 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 3 points regarding complaint bearing Nos. 2019-24366, 2019-24207 & 2019-24679 i.e. copy of complaint along with its annexures and action taken report/progress report etc.

Comments of CPIO/Central:

CPIO/Central submitted that RTI application of the appellant was received through online RTI portal for supplying the requisite information. Thereafter, requisite information was denied u/s 8(1)(h) of RTI

Act as the complaint Nos. 2019-24366, 2019-24207 & 2019-24679 were under enquiry with his office.


Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant sought information on 3 points regarding complaint bearing Nos. 2019-24366, 2019-24207 & 2019-24679 i.e. copy of complaint along with its annexures and action taken report/progress report etc.

In reply, CPIO/Central had denied u/s 8(1)(h) of RTI Act as the complaint Nos. 2019-24366, 2019-24207 & 2019-24679 were under enquiry with his office.

Insofar instant appeal is concerned, complaint in questions i.e. 2019-24366, 2019-24207 & 2019-24679 are still under enquiry, therefore, enquiries report cannot be supplied to the appellant at this point of time. However, considering that appellant is either complainant or alleged in these complaints, therefore, CPIO/Central is hereby directed to supply the copies of above said complaints to the appellant. With these observations, the instant appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
