### ORDER

The appellant has preferred his online 1st appeal (bearing registration No. PODEP/A/E/20/00082 dated 28.10.2020) against the reply of CPIO/PHQ in connection with his RTI application (bearing registration No. PODEP/R/E/20/00445 dated 19.09.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 121/UT/RTI/FAA/SSP dated 29.09.2020 for further proceeding under RTI Act.

## INFORMATION SOUGHT VIDE RTI APPLICATION:-

The appellant has sought information with regard to his complaint bearing No. 2020-09684 i.e. complete file, all noting /documents, statements & orders.

## COMMENTS OF CPIO/PHQ:-

Comments of CPIO/PHQ have been obtained who submitted that RTI application of the appellant was received through online RTI portal for obtaining requisite information. Appellant was informed that complaint

in question 2020-09684 was under consideration with senior officer, hence, the same is denied u/s 8(1)(h) of RTI Act.

#### DECISION:-

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant has sought information with regard to his complaint bearing No. 2020-09684 i.e. complete file, all noting/documents, statements & orders.

It is clear from the reply of CPIO/PHQ as well as record in hand that complaint in question {2020-09684} is still under consideration, hence, the same cannot be supplied at this stage. Therefore, CPIO/PHQ has rightly denied by applying section 8(1)(h) of RTI Act.

Moreover, considering that appellant is complainant in complaint in question, hence, CPIO/PHQ is hereby directed to supply the requisite information to him, free of cost, in accordance with RTI Act as and when the above said complaint is finalized. With these directions, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
