**ORDER**

The appellant has preferred his online 1<sup>st</sup> appeal (bearing registration No. PODEP/A/E/20/00085 dated 09.11.2020) against the reply of CPIO/Central in connection with his RTI application (bearing registration No. PODEP/R/E/20/00470 dated 03.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 126/UT/RTI/FAA/SSP dated 11.11.2020 for further proceeding under RTI Act.

**INFORMATION SOUGHT VIDE RTI APPLICATION:-**

The appellant has sought information on two points pertaining to Stolen Vehicle No. PB06AF 9343 from outside house No. 3335 Sector 23, Chandigarh on 27.08.2020 i.e. reporting time of stolen vehicle and name of FIR along with recovery status of stolen vehicle

**COMMENTS OF CPIO/Central:-**

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received through online RTI portal for obtaining requisite information. After obtaining report from SHO/PS-17,

requisite information was supplied vide No. 266/RTI-20/CPIO/Central dated 27.10.2020 to appellant i.e. reporting time of stolen vehicle and name of FIR along with recovery status of stolen vehicle. Therefore, no more information is required to be supplied at this stage and RTI appeal may be filed, please.

**DECISION:-**

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant has sought on two points pertaining to Stolen Vehicle No. PB-06AF-9343 from outside house No. 3335 Sector 23, Chandigarh on 27.08.2020, i.e. reporting time of stolen vehicle and name of FIR along with recovery status of stolen vehicle

So far appeal is concerned, it is clear that case FIR No. 157 dated 31.08.2020 u/s 379 IPC is under investigation and no clue has come to light regarding stolen vehicle No. PB-06AF-9343. Moreover, CPIO/Central had already has already been supplied the requisite information to the appellant, hence, no more action is required to be taken and the same is hereby filed.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
