### ORDER

This is an order on the appeal dated 05.08.2019 received through E-mail dated 05.08.2019 in this office, preferred by Ms Navjot Lehal R/o # F-144, Ph- 8/B, Indl. Area, I.T. City, Mohali, (Punjab), under RTI Act, 2005 for not supplying proper information by CPIO-cum DSP/Crime.

#### **Facts:-**

**2. Vide RTI application dated 27.06.2019,** the appellant had sought information on points nos. 5 (A) to 5 (I) points (pertaining to compliance by Chandigarh Police of orders dated 15.04.2019 passed by Police Complaint Authority in complaint no.14/2017), out of which, she appealed against the reply of CPIO - cum-DSP/Crime with regard to points nos. 5 (A), (c), (D), (E) & (G).

**3. The Comments of CPIO-cum-DSP/Crime** was sought vide No 50/A/FA/RTI/SP/Hqrs. dated 05.08.2019, who intimated that information in point-wise form has already been supplied to the appellant, vide letter No. 38/RTI/CPIO/Crime dated 26.07.2019.

### **DECISION**

4. I have considered the RTI application & appeal filed by the appellant viz-a-viz comments of CPIO-cum- DSP/Crime which revealed that points raised by the appellant vide her 1st appeal and their compliance is as under :

5.(A) I be supplied certified copy of SEIZURE MEMO vide which DVR containing CCTV footage dated 23.02.2017 of all five Cameras fixed in the said Ajanta Society was taken into police possession in compliance with said PCA order.

Reply : All the process of obtaining the CCTV footages and DVR from Ajanta Cooperative Housing Building (1<sup>st</sup>) Society, Sector 51 D, Chandigarh was conducted under the close supervision of senior officers and the certified copies of all available documents including seizure memos vide which CCTV footage taken into possession in connection with case FIR nos. 19 & 20/2017, PS Sector 49, Chandigarh etc. were obtained from SI Jasbir Singh, 976/CHG and provided to the appellant. Moreover, DVR of the cameras is deposited with CFSL for examination and result is still awaited.

5.(C) I be supplied certified copy of all the CFSL Letters /Reports/Findings/Clarifications etc sought /given in this matter.

Reply : All the available CFSL letters/Reports/Findings/Clarifications/ Communications etc. were provided to the appellant

5.(D) I be supplied certified copy of complete unedited CCTV footage dated 23.02.2017 of all five cameras installed in Ajanta Society of Crime scene of Two hours each (Time period 4:00 PM to 6:00 PM), i.e. CCTV footage running into 10 hours.

Reply : The requisite information/footage in the shape of two CDs obtained from SI Jasbir Singh, 976/CHG, who had seized the same during investigation of case FIR nos. 19 & 20/2017, PS Sector 49, Chandigarh, has already been provided to the appellant. Moreover, the same information has also been provided to the appellant in compliance of orders of Hon'ble CIC.

5.(E) I be supplied certified copy of seizure memo vide which CCTV footage dated 23.02.2017 (of all five cameras installed in Ajanta Society of crime scene of Two hours each Time period (4:00 PM to 6:00 PM), i.e. CCTV footage running into 10 hours was in Police possession with Crime Branch Sector- 11, Chandigarh, as said CCTV footage was also shown on 11.03.2017 in DSP Crime Office to applicant/complainant and her family.

Reply : Already provided as replied in point no. 5(A). The point is repeated.

5(G) I be supplied certified copy of said CCTV footage dated 23.02.2017 of crime scene of two CCTV cameras ("main gate and meeting") of Time period (4:00PM to 6:00PM) As admitted by DSP(Crime) Sukhraj Katewa before CIC in my RTI second appeal and Hon"ble CIC vide tis order dated 08.04.2019 has specifically " directs the CPIO to provide complete information sought ... .. after procuring the same from the concerned court along with the digital file size of relevant time of two functional CCTV Cameras, free of cost" which CPIO-cum-DSP(Crime) Sukhraj Katewa has NOT provided to applicant till date.

Reply : Already provided as replied in point no. 5(D). The point is repeated.

In views of above, it is categorically clear that the necessary reply/information to her RTI application has already been provided by the CPIO/Crime, as such, the appeal is hereby disposed of, accordingly.
