ORDER

The appellant has preferred his online 1st appeal (bearing registration No. PODEP/A/E/20/00088 dated 14.11.2020) against the reply of CPIO/W&CSU in connection with his RTI application (bearing registration No. PODEP/R/E/20/00521 dated 28.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 128/UT/RTI/FAA/SSP dated 14.11.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:-

The appellant has sought copy complaint against him along with action taken report etc.

COMMENTS OF CPIO/W&CSU:-

Comments of CPIO/W&CSU have been obtained who submitted that RTI application of the appellant was received through online RTI portal for obtaining requisite information. Accordingly, appellant was informed that no case/complaint has been received against the appellant.

COMMENTS OF CPIO/South:-

Comments of CPIO/South have been obtained who submitted that RTI application of the appellant was received through online RTI portal for obtaining requisite information. Thereafter, report from all SHOs of Sub division South were obtained, accordingly, SHO/39 reported that complaint bearing No.

2020-19506 made by Rajesh Bansal against Sanjay, GMSH-41 Badeheri is under enquiry, hence, requisite information was denied u/s 8(1(h) of RTI Act. Moreover, preventive action u/s 107/151 Crpc vide DDR No. 38 dated 03.10.2020 has been initiated against Sanjay which is under trial in Ld. SDM/Court.

DECISION:-

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/W&CSU & South vis-à-vis material available on record which revealed that appellant has sought copy complaint against him along with action taken report etc.

So far appeal is concerned, from the reply of CPIO/South, it is clear that complaint bearing no. 2020-19506 is under enquiry against the appellant and copy of above complaint can be furnished to him. Moreover, preventive action u/s 107/151 Crpc vide DDR No. 38 dated 03.10.2020 has also been initiated against Sanjay, therefore, copy of aforesaid DDR can also be supplied to him.

In view of above CPIO/South is hereby directed to supply the requisite information as discussed above as per RTI Act. With these directions, instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
