ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 11/UT/RTI/FAA/SSP dated 02.02.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 13 points pertaining to complaint Nos. 2019-23427 & 2019-23916 and case FIR No. 05 dated 04.01.2020, PS-39, Chandigarh.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that appellant has sought information RTI application and thereafter report from SHO/PS-17 was obtained who reported that requisite information on point No. 1 & 2 was consigned in HAC Branch after completion of enquiry; information on point Nos. 3, 10 & 13 was furnished to the appellant and information on point No. 4 & 5 was denied by applying section 8(1)(g)(j) of RTI Act. Moreover, information on point No. 6 to 9 and 11 & 12 was not covered u/s 2 (f) of RTI Act.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record

which revealed that appellant had sought information on 13 points pertaining to complaint Nos. 2019-23427 & 2019-23916 and case FIR 05 dated 04.01.2020, PS-39, Chandigarh.

Insofar appeal is concerned, it is clear that information pertaining to point No. 1 & 2 (i.e. complaint bearing No. 2019-23427 & 2019-23916 respectively) are consigned with HAC Branch after competition of enquiry, therefore, the same can be furnished to the appellant.

Moreover, on perusal of contents of point No. 4 & 5, it revealed that appellants wants to know the vehicles and its details which is used during his medical examination and lodging him in jail which is not a personal information of any person and the same can be furnished to him.

On perusal of point nos. 6 to 9, 11 & 12, it revealed that appellant is raising his queries & grievances which cannot be redressed under RTI Act, hence, CPIO/South had aptly applied section 2 (f) of RTI Act.

Whereas, information on point No. 3, 10 & 13 has already been supplied to the appellant, hence, no more action is required to be taken on these points.

In view of above, CPIO/South is hereby directed to furnish forthwith the requisite information to the appellant free of cost, as observed above. Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
