**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply of CPIO/Central & PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 128/UT/RTI/FAA/SSP dated 14.11.2020 for further proceeding under RTI Act.

**INFORMATION SOUGHT VIDE RTI APPLICATION:-**

The appellant has sought information on four points pertaining to his complaint bearing No. 2020-16406 & 2020-15754.

**COMMENTS OF CPIO/PHQ:-**

Comments of CPIO/PHQ have been obtained who submitted that RTI application of the appellant was received from Public window for supplying the requisite information. Thereafter, RTI application was transferred vide No. 606/DSP/Hqrs/RTI-2020, D-883 dated 19.10.2020 to the CPIO/Central as I/C CRU reported that complaint bearing No. 202-16406 has sent to DSP/Central for enquiry

**COMMENTS OF CPIO/CENTRAL:-**

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received for obtaining requisite information. Thereafter, point-wise information was furnished vide No. 277 & 286/RTI-20/CPIO-Central dated 02.10.2020.

## **DECISION:-**

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central & PHQ vis-à-vis material available on record which revealed that appellant has sought information on four points pertaining to his complaint bearing No. 2020-16406 & 2020-15754.

So far as the appeal is concerned, it is clear that the complaints in question i.e. 2020-16406 & 2020-15754 are under consideration for final decision, therefore, the same cannot be supplied at this stage u/s 8(1) (h) of RTI Act.

However, taking note of the fact, appellant is complainant in the aforementioned complaints, hence, CPIO/Central is hereby directed to supply the requisite information as and when his complaints are finalized. With these directions, the instant appeal stands disposed of.

In view of above CPIO/Central is hereby directed to supply the requisite information as discussed above as per RTI Act. With these directions, instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
