ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 132/UT/RTI/FAA/SSP dated 19.11.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:-

The appellant has sought copies of complaints along with its complete proceedings pertaining to his complaints bearing No. pertaining to complaints No. 2019-05146, 2019-11233, 2019-10527 & 2019-12215.

COMMENTS OF CPIO/CENTRAL:-

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received for obtaining requisite information pertaining to complaints No. 2019-05146, 2019-11233, 2019-10527 & 201912215. Thereafter, copies of above said complaints were supplied to the appellants and other documents/information were denied u/s 8(1)(h) of RTI Act vide No. 271/RTI-20/CPIO-Central dated 14.10.2020.

DECISION:-

I have carefully gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant has sought copies of complaints along with its complete proceedings pertaining to his complaints bearing No. pertaining to complaints No. 2019-05146, 2019-11233, 2019-10527 & 2019-12215.

So far as the appeal is concerned, it clear from the record in hand that the complaints in question (bearing No. 2019-05146, 2019-11233, 2019-10527 & 2019-12215) are still under enquiry, therefore, CPIO/Central has appropriately applied section 8(1) (h) of RTI Act as appellant is alleged and by supplying requisite information at this stage of enquiry would impede the process of enquiry. Moreover, CPIO/Central had submitted that copies of complaints had already been supplied to appellant; hence, the instant appeal is hereby filed.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
