ORDER

The appellant has preferred his online 1st appeal (bearing registration no. PODEP/A/E/20/00091 dated 12.11.2020) against the reply/order of CPIO/Central in connection with his online RTI application (bearing registration no. PODEP/R/E/20/000502 dated 19.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 134/UT/RTI/FAA/SSP dated 20.11.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 9 points pertaining to bearing nos. 2020-15541 & 2020-18889.

COMMENTS OF CPIO/CENTRAL: -

CPIO/Central submitted that online RTI application of the appellant was received online for supplying information. After obtaining report from SHO PS Sarangpur, point-wise information/reply was supplied to the appellant. He further submitted that appellant had sought

information on question mode and no documents were sought. However, point wise reply was given to him.

DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 9 points pertaining to bearing nos. 2020-15541 & 2020-18889.

Insofar appeal is concerned, it is clear from the record in hand that complaint bearing no. 2020-15541 has been finalized and consigned in HAC Branch. Therefore, requisite information can be supplied to the appellant.

Further, complaint bearing No. 2020-18889 is still under enquiry, therefore, the same cannot be supplied at this stage to the appellant under section 8(1)(h) of RTI Act. Moreover, appellant has raised queries pertaining to aforementioned complaints which is out of purview under section 2 (f) of RTI Act.

In view of above, CPIO/Central is directed to supply the requisite information pertaining to complaint no. 2020-15541 as per RTI Act. With these directions, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
