ORDER

The appellant has preferred his 1st appeal through online RTI portal bearing No. PODEP/A/2019/60053 dated 29.07.2019 against the reply/order of CPIO/South in connection with his online RTI application bearing No. PODEP/R/2019/50456 dated 25.06.2019 with the contentions that information on point No. 1 to 5 was not supplied to him. The instant appeal was diarized vide No. 146/UT/RTI/ FAA/SSP dated 29.07.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information with regard to FIR No. 372/2018 i.e. copy of FIR, CFSL & MLR, statements and Mechanical/fitness report of vehicle involved in the FIR etc.

Comments of CPIO/South:

CPIO/South submitted that RTI application of the appellant was received through online RTI portal for supplying the requisite information pertaining to Case FIR no. 372/2018. After obtaining the report from SHO/PS-36, point wise reply was provided vide letter No. 381/RTI/CPIO/South dated 08.07.2019. As far as appeal is concerned, all the relevant documents are attached with the aforementioned case file which is presently under trial in the court. Moreover, CPIO is ready to arrange the inspection of police file to the appellant.

Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information with regard to FIR No. 372/2018 i.e. copy of FIR, CFSL & MLR, statements and Mechanical/fitness report of vehicle involved in the FIR etc.

In reply, CPIO/South had submitted that point wise reply was supplied to the appellant.

So far as the appeal is concerned, CPIO/South has asserted that case FIR No. 372/2018 has already been presented in the court for trial and the requisite information is attached with case file. However, CPIO further submitted that he is ready to arrange the inspection of police file to the appellant.

In view of above, CPIO/South is hereby directed to follow the provision of Section 11 of RTI Act before arranging the inspection of the police file of case FIR No. 372/2018 and if conditions of section 11 are fulfilled, supply the available information to the appellant as per RTI Act.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
