ORDER

The appellant has preferred his 1st appeal through online RTI portal bearing No. PODEP/A/2019/60055 dated 09.08.2019 against the reply/order of CPIO/South in connection with his online RTI application bearing No. PODEP/R/2019/50489 dated 09.07.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 151/UT/RTI/ FAA/SSP dated 09.08.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 5 points on various issues i.e. action taken report upon complaint No. 2019-09601, whether any statement recorded in the said complaint, copy of FIR etc.

Comments of CPIO/South

CPIO/South submitted that RTI application of the appellant was received through online RTI portal for supplying of requisite information. After obtaining the report from SHO/PS-31, information on point No. 1 & 3 was denied u/s 8(1) (h) of RTI act and information on point No. 2, 4 & 5 was furnished to the applicant vide letter No. 419+431/CPIO/South dated 05.08.2019.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on 5 points on various issues i.e. action taken report upon complaint No. 2019-09601, whether any statement recorded in the said complaint, copy of FIR etc.

In reply, CPIO/South denied the information on point No. 1 & 3 u/s 8(1) (h) of RTI act and information on point No. 2, 4 & 5 was furnished to the applicant.

So far as the appeal is concerned, complaint in question i.e. 2019-09601 is still under enquiry, therefore, information on point No. 1 & 3 cannot be supplied at this stage. Moreover, the appellant has sought information vide other points in questionable form like whether, what, why and when. The same is not come under the ambit of section 2 (f) & (j) RTI Act as it is categorically clarified in these sections that applicant can ask for the information which is available in any material form with the CPIO.

However, taking note of the fact that appellant is complainant in the aforementioned complaint; CPIO/South is hereby directed to apprise the present status/progress of the complaint to the appellant. With these observations, instant appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal within 90 days before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act.
