ORDER

The appellant has preferred his online 1st appeal (bearing registration no. PODEP/A/E/20/00093 dated 01.12.2020) against the reply/order of CPIO/South in connection with his online RTI application (bearing registration no. PODEP/R/E/20/000508 dated 23.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 139/UT/RTI/FAA/SSP dated 01.12.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought status of compliant No. 2020-14418 including action taken Report.

COMMENTS OF CPIO/South: -

CPIO/South submitted that RTI application of the appellant was received for supplying information. After obtaining report from SHO/34, appellant was informed vide No. 455/CPIO/South dated 24.10.2020 that compliant in question was under enquiry at that time and denied u/s 8(1)(h) of RTI Act.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought status of compliant No. 2020-14418 including Action Taken Report.

Insofar appeal is concerned that it is clear from the reply of CPIO/South that complaint in question is still under enquiry, therefore, Action Taken report cannot be supplied at this stage. Hence, CPIO/South had correctly applied section 8(1) (h) of RTI Act and no more action is required to be taken in the instant appeal and it is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
