ORDER

Comments of CPIO/PHQ-cum-RTI Nodal Officer:

CPIO/PHQ-cum-RTI Nodal Officer submitted that RTI application of the appellant was received through online RTI portal and the same was returned to the appellant with the remarks that he had not mentioned complete particulars i.e. complaint No. DDR/FIR No. & name of Police Station and he is requested to file fresh RTI application with complete particulars of the requisite information. Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ-cum-RTI Nodal Officer vis-à-vis

material available on record which revealed that the appellant had sought copy of FIR with regard to his various emails dated 29.07.2019.

In reply, CPIO/PHQ-cum-RTI Nodal Officer returned the RTI application of the applicant as there were not full particulars of information required.

So far as the appeal is concerned, appellant has now provided the copy of email dated 29/07/2019 sent to the official email of W/DGP/UT as well as I/C PP-ISBT 43. Hence, CPIO/PHQ-cum-RTI Nodal Officer is hereby directed to transfer the RTI application to the appropriate CPIO(s) for supplying the requisite information to the appellant.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
