ORDER

The appellant has preferred her 1st appeal against the reply/order of CPIO/East in connection with RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 137/UT/RTI/FAA/SSP dated 27.11.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copy of complaint filed by Ms. Daljeet Kaur, Asst. Clerk against Guru Nanak Khalsa School Sector 30B, Chandigarh along with notice issued by PS-Ind. Area.

COMMENTS OF CPIO/East: -

CPIO/East submitted that RTI application of the appellant was received for supplying information. After obtaining report from SHO/PS-Ind. Area, requisite information was denied u/s 8(1) (h) of RTI Act as the complaints in question was under enquiry at that time.

DECISION :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought copy of complaint filed by Ms. Daljeet Kaur, Asst. Clerk against Guru Nanak Khalsa School Sector 30B, Chandigarh along with notice issued by PS-Ind. Area.

It is clear from the contents of RTI application that appellant had sought only copy of complaint along with notice bearing No. 1346-3A/5A/PSI-Indl dated 05.11.2020, which can be supplied, though complaint is still under enquiry. Hence, CPIO/East is hereby directed to supply the same forthwith, free of cost to the appellant. With this direction, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
