ORDER

The appellant has preferred her 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 153/UT/RTI/FAA/SSP dated 16.08.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 4 points pertaining to death of her husband Lavneet Gupta i.e. copies of DDR entries dated 20.05.2016 & 21.05.2016, total pages of case file, copy of enquiry report conducted by PS-39 etc.

Comments of CPIO/South:

CPIO/South submitted that RTI application of the appellant was received on 09.07.2019 for supplying the requisite information. After obtaining the report from SHO/PS-39, the point wise information/documents was supplied vide letter No. 426/CPIO/South dated 25.07.2019 after receiving additional fee of Rs. 60/- from the applicant.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on

record which revealed that the appellant had sought information on 4 points pertaining to death of her husband Lavneet Gupta i.e. copies of DDR entries dated 20.05.2016 & 21.05.2016, total pages of case file, copy of enquiry report conducted in PS-39 etc.

In reply, CPIO/South submitted that point wise reply/information was supplied to the appellant.

So far as the appeal is concerned, from the reply of CPIO/South, it is clear that point wise information i.e. copies of DDR entries dated 20.05.2016 & 21.05.2016, copies of complete police file and enquiry report was already furnished to the appellant. However, considering the fact that appellant is not satisfied with the information provided to her. Hence, CPIO/South is hereby directed to arrange the inspection of relevant file to the appellant and supply the requisite information to her as per RTI Act.

With these observations, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal within 90 days before the IHon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act.
