ORDER

The appellant has preferred her 1st appeal through online RTI portal bearing No. PODEP/A/2019/60059 dated 25.08.2019 against the reply/order of CPIO/PHQ & CCIC in connection with his online RTI application bearing No. PODEP/R/2019/50417 dated 02.06.2019 with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 156/UT/RTI/ FAA/SSP dated 26.08.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information pertaining to her complaint bearing No. 2018-21419 i.e. closure report including all documents.

Comments of CPIO/CCIC

CPIO/CCIC submitted that RTI application of the appellant was received on RTI online portal for supplying the requisite information pertaining to her complaint No. 2018-21419. The report into the matter has already been sent to senior officer vide No. C-3246/DSP/CCIC&IT dated 20.05.2019. At present, the same is consigned to record with I/C HAC Branch.

Comments of CPIO/PHQ

CPIO/PHQ submitted that RTI application of the appellant was received through online RTI portal for supplying of requisite information. Thereafter report from I/C CRU was obtained who reported that complaint No.

2018-21419 was under consideration for final decision with senior officers, therefore, the same cannot be supplied u/s 8(1)(h) of RTI Act. Accordingly, appellant was informed vide letter No. 270/DSP/Hqrs./Online RTI-19, D-323 dated 28.06.2019 as well as through RTI Portal.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ & CCIC vis-à-vis material available on record which revealed that the appellant had sought information pertaining to her complaint bearing No. 2018-21419 i.e. closure report including all documents.

In reply, CPIO/PHQ denied the requisite information u/s 8(1) (h) of RTI Act as the complaints No. 2018-21419 was under enquiry at that time.

So far as the appeal is concerned, the present status of complaint in question i.e. 2018-21419 is consigned in record of I/C HAC branch after completion of enquiry, therefore, the same can be provided at this stage.

Hence, CPIO/PHQ is hereby directed to supply the requisite information to the appellant as per RTI Act.

With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal within 90 days before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act.
