ORDER

The appellant has preferred his 1st appeal through online RTI portal bearing No. PODEP/A/2019/60065 dated 05.09.2019 against the reply/order of CPIO/South in connection with his online RTI application bearing No. PODEP/R/2019/50573 dated 18.08.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 165/UT/RTI/FAA/SSP dated 05.09.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought action taken report to his compliant dated 29.07.2019.

Comments of CPIO/South

CPIO/South submitted that as per report of SHO/PS-36, compliant bearing No. 2019-14113 was received against Aggarwal Packers & Movers. The said complaint is still pending for enquiry as the complainant has not joined the enquiry inspite of repeated request was made to him for joining enquiry.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on

record which revealed that the appellant had sought action taken report to his complainant dated 29.07.2019.

In reply, CPIO/South submitted that complaint in question i.e. 2019-14113 is still under enquiry and complainant has not joined the enquiry yet.

So far as the appeal is concerned, from the perusal of the record in hand, it is clear that the complaint in question i.e. 2019-14113 is pending under enquiry as complainant/appellant has not joined the enquiry yet. Thus, action taken report in the aforementioned complaint cannot be supplied at this stage.

However, taking note of the fact that appellant is complainant of complaint No. 2019-14113, CPIO/South is hereby directed to supply the requisite information in accordance with RTI Act as and when the same is finalized.

With these observations, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
