**ORDER**


The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 166-168/UT/RTI/FAA/SSP dated 09.09.2019 for further proceeding under RTI Act.

**Information sought vide RTI application:**

The appellant had sought complete file of his complaint bearing No. 2019-11341.

**Comments of CPIO/PHQ**

CPIO/PHQ submitted that RTI application of the appellant was received from CAPIO, PHQ vide letter No. 1730/CAPIO/PHQ/UT/PWS dated 19.08.2019 for supplying the requisite information. Thereafter, report from DDA Legal was obtained, who reported that complaint in question i.e. PW 2019-11341 was under consideration with senior officers which cannot be supplied at that time. In this regard, appellant was informed vide letter No. 1265/DSP/Hqrs./RTI-19, D-1241 dated 05.09.2019 that requisite information was denied u/s 8(1)(h) of RTI Act.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that the appellant had sought complete file of his complaint bearing No. 2019-11341.

In reply, CPIO/PHQ had denied the requisite information u/s 8(1)(h) of RTI Act as complaint in question i.e. 2019-11341 was under consideration at that time.

So far as appeal is concerned, it is clear from record of Public Window that present status of complaint in question i.e. 2019-11341 is consigned in record of I/C HAC branch after completion of enquiry, therefore, the same can be supplied.

Hence, CPIO/PHQ is hereby directed to supply the requisite information to the appellant as per RTI Act.

With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
