The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 13/UT/RTI/FAA/SSP dated 26.02.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 06 points pertaining to complaints bearing No. 2020-5924 i.e. copy of complaint, statements and status of complaints etc.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that application of the appellant was received for supplying requisite information and report from SHO/PS-39 was obtained, thereafter, name of I/O, copy of complaint and statements recorded was supplied to the appellant and rest of the information was denied u/s 8(1)(h) of RTI Act as complaint bearing No.

2020-05924 was under enquiry. Appellant was informed in this regard vide letter No. 62/CPIO/South dated 12.02.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 06 points pertaining to complaints bearing No. 2020-5924 i.e. copy of complaint, statements and status of complaints etc.

Insofar appeal is concerned, it is clear from the reply of CPIO/South that complaint in question is still under enquiry and copy of complaint, statements and name of enquiry officer have already been supplied to the appellant. Hence, CPIO/South had aptly applied section 8(1)(h) of RTI Act, hence, no more action is required in appeal.

Appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
