ORDER

The appellant has preferred his first appeal against the reply/order of CPIO/PHQ, Accounts and Establishment in connection with his RTI application received on 05.08.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 172/UT/RTI/FAA/SSP dated 18.09.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 04 points pertaining to Mukesh Kumar, former PA to SSP/Sec. & Traffic i.e. his leave record, salary details, permissions of Court cases and term & conditions of his deputation from Public Health Department to Chandigarh Police etc.

After receipt of appeal, RTI application and attached documents, the same were perused thoroughly which revealed that RTI application was also dealt by CPIO/Accounts and Establishment. **Hence, instant appeal has been transferred to FAA-cum-AC(F&A) vide no. D-566/UT/RTI/FAA/SSP dated 19.09.2019.**

Comments of CPIO/PHQ :

CPIO/PHQ submitted that RTI application of the appellant was received from CPIO/PHQ vide letter No. 1662/RTI/CPIO/PHQ/UT/PWS dated 08.08.2019 for supplying requisite information. Thereafter, contents of RTI application were perused thoroughly which revealed that requisite information was primarily related with

CPIO/Establishment, hence, RTI application was transferred to CPIO/Establishment vide letter no. 1215/DSP/Hqrs/RTI-19/D-1182 dated 22.08.2019.

Decision :


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant had sought information on 04 points pertaining to Mukesh Kumar, former PA to SSP/Sec. & Traffic i.e. his leave record, salary details, permissions of Court cases and term & conditions of his deputation from Public Health Department to Chandigarh Police etc.

In reply, CPIO/PHQ has informed the appellant that RTI application was transferred to CPIO/Establishment vide letter no. 1215/DSP/Hqrs/RTI-19/D-1182 dated 22.08.2019 as the contents of RTI application were primarily related with CPIO/Establishment.


So far as the appeal is concerned, it is manifestly clear that RTI application has already been transferred to CPIO/Establishment and no information was supplied by CPIO/Hqrs to the appellant. Hence, no more action is required to be taken by the undersigned.

With these observations, the instant appeal stands filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
