**ORDER**

The appellant has preferred her 1<sup>st</sup> appeal through online portal (bearing No. PODEP/A/E/20/00005 dated 09.02.2020) against the reply/order of CPIO/Central in connection with her RTI application (bearing No. PODEP/R/2019/50775 dated 10.12.2019) with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 12/UT/RTI/FAA/SSP dated 10.02.2020 for further proceeding under RTI Act.

**Information sought vide RTI application:**

The appellant had sought the copy of action taken report on complaint No. PW 201908506 dated 13.05.2019.

**Comments of CPIO/Central:**

CPIO/Central submitted that RTI application of the appellant was received through online RTI portal for supplying the action taken report on complaint No. PW 201908506 dated 13.05.2019. Thereafter, requisite information was obtained from SHO/PS-17 and the information was denied to the appellant u/s 8(1)(h) of RTI Act as the complaint Nos. 2019-08506 was under enquiry at that time. At present, the complaint in question has been sent to Police Headquarter after completion of enquiry. Being complainant, appellant was contacted on her phone and apprised about the latest status of her complaint.

**Decision:**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record

which revealed that the appellant sought the copy of action taken report on complaint No. PW 201908506 dated 13.05.2019.

In reply, CPIO/Central had denied the requisite information u/s 8(1)(h) of RTI Act as the complaint Nos. 2019-08506 was under enquiry at that time.

Insofar instant appeal is concerned, CPIO/Central has rightly denied the requisite information to the appellant. However, CPIO/Central is hereby directed to cooperate with the appellant, being complainant and apprise the latest status of complaint to her. CPIO/Central is further directed to supply the requisite information to the appellant as per RTI Act as and when the complaint is consigned to record after completion of enquiry.

With these observations, the instant appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
