ORDER

The appellant has preferred his online 1st appeal vide registration no. PODEP/A/2019/60070 against the reply/order of CPIO/East in connection with his RTI application bearing no. PODEP/R/2019/80024 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 172/UT/RTI/FAA/SSP dated 19.09.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information pertaining to his complaints sent via e-mail on various dates.

Comments of CPIO/East :

CPIO/East submitted that RTI application of the appellant was received through online RTI portal vide registration no. PODEP/R/2019/80024 dated 29.08.2019 for supplying information pertaining to complaint sent by him via e-mail on various dates. Thereafter, requisite information was obtained from SHO PS Sector 26, Chandigarh who submitted that complaints bearing nos. 2019-00380, 2019-00736, 2019-05603, 2019-09262, 2019-11165, 2019-11419 & 2019-12162 of the appellant were under enquiry at that stage. Hence, the requisite information was denied u/s 8(1)(h) of RTI act. As far as the present status of the complaints are concerned, the above said complaints are still under enquiry.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought information pertaining to his complaints sent via e-mail on various dates.

In reply, CPIO/East had denied the requisite information to the appellant u/s 8(1)(h) of RTI act as the complaints of the appellant bearing nos. 2019-00380, 2019-00736, 2019-05603, 2019-09262, 2019-11165, 2019-11419 & 2019-12162 were under enquiry at that time.

So far as the appeal is concerned, the complaints in question are still under enquiry. Hence, CPIO/East has rightly denied the requisite information to the appellant u/s 8(1)(h) of RTI act. However, considering the fact that appellant is complainant in all complaints, CPIO/East is hereby directed to cooperate with the appellant as and when he approaches him and supply the requisite information as per RTI act as and when the enquiries are completed.

With these observations, the instant appeal stands filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
