#### **ORDER**

The appellant has preferred his online 1<sup>st</sup> appeal vide registration no. PODEP/A/2019/60068 against the reply/order of CPIO/South in connection with his RTI application bearing no. PODEP/R/2019/50577 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 170/UT/RTI/FAA/SSP dated 17.09.2019 for further proceeding under RTI Act.

## Information sought vide RTI application:

The appellant had sought information pertaining to his complaint bearing no. 2019-11861 dated 01.07.2019.

#### Comments of CPIO/South:

CPIO/South submitted that RTI application of the appellant was received through online RTI portal vide registration no. PODEP/R/2019/50577 dated 20.08.2019 for supplying information pertaining to complaint bearing no. 2019-11861 dated 01.07.2019. Thereafter, requisite information was obtained from SHO PS Sector 49, Chandigarh who submitted that complaint in question was under enquiry at that time hence the information was denied u/s 8(1)(h) of RTI act. As far as the present status of the complaint is concerned, the complaint in question has been sent to senior officers for further necessary action.

### Personal Hearing:

Personal hearing in the matter was conducted on 14.10.2019. The issue was discussed in detail upon which, it was decided that requisite information will be supplied to the appellant as and when the enquiry is finalized and consigned to record.

#### Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information pertaining to his complaint bearing no. 2019-11861 dated 01.07.2019.

In reply, CPIO/South had denied the requisite information to the appellant u/s 8(1)(h) of RTI act as the complaint in question (2019-11861) was under enquiry at that time.

So far as the appeal is concerned, the complaint in question is still under enquiry and yet to be finalized. Hence, CPIO/South has rightly denied the requisite information to the appellant u/s 8(1)(h) of RTI act. However, considering the fact that appellant is complainant, CPIO/South is hereby directed to supply the requisite information to the appellant as per RTI act as and when the enquiry is finalized.

With these observations, the instant appeal stands filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
