ORDER

The appellant has preferred her 1st appeal against the reply/order of CPIO/Central in connection with her RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 174/UT/RTI/FAA/SSP dated 20.09.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought status of her complaint bearing No. 2019-09848 and status of her lost mobile Phone.

Comments of CPIO/Central

CPIO/Central submitted that RTI application of the appellant was received from CAPIO, PHQ vide letter No. 1696/CAPIO/PHQ/UT/PWS dated 13.08.2019 for supplying the requisite information. Thereafter, report from SHO/PS-17 was obtained, who reported that complaint bearing No. 2019-09848 dated 31.05.2019 was received at PP-Neelam vide No. 590-5C/PS-17 dated 06.06.2019. After completion of inquiry said complaint was sent to Senior Officer on 27.07.2019. In this regard, an e-mail was sent to MTMC, Sector 9, Chandigarh to put the IMEI number of said mobile phone on surveillance on 19.07.2019 but till date no positive report came to notice. In this regard, applicant was informed by post 26.08.2019.

Moreover, appeal of the appellant has also been transferred to the First Appellate Authority-cum-Superintendent of Police, PHQ, Sector-9, UT, Chandigarh as the said RTI application was also dealt by CPIO/Crime.

Decision :


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought status of her complaint and status of her lost mobile Phone.

In reply, CPIO/Central submitted that an e-mail was sent to MTMC, Sector 9, Chandigarh to put the IMEI number of said mobile phone under surveillance on 19.07.2019 but till date no positive report came to notice. Moreover, complaint bearing No. 2019-09848 dated 31.05.2019 was under inquiry at that time. In this regard, applicant was informed by post 26.08.2019.

So far as the appeal is concerned, it is evidently clear from the reply of CPIO/Central that IMEI number of the mobile number has been put under surveillance and no clue of said mobile was traced till date. However, as far as compliant in question i.e. 2019-09848 is concerned, the same is still under enquiry.

In view of above, CPIO/Central is hereby directed to supply the requisite information to the appellant with regard to aforementioned complaint as and when it was finalized. With these observations, the instant appeal is hereby disposed of as far as this office is concerned.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
