### ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/East in connection with her RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 179/UT/RTI/FAA/SSP dated 27.09.2019 for further proceeding under RTI Act.

## Information sought vide RTI application:

The appellant had sought information on 03 points but he raised the instant appeal with regard to point No. 3 i.e. certified copy of jurisdiction map of Police Station Mauli Jagran.

## Comments of CPIO/East

CPIO/East submitted that RTI application of the appellant was received from CAPIO, PHQ vide letter No. 1635/CAPIO/PHQ/UT/PWS dated 02.08.2019 for supplying the requisite information. Thereafter, after obtaining the requisite information from SHO/PS-MJ, the same were provided to the appellant vide letter No. 395-RTI/CPIO/East dated 27.08.2019. Moreover, the copy of jurisdiction map of PS-MJ is also available on the official website of Chandigarh Police.

#### Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which

revealed that appellant had sought information on 03 points but he raised the instant appeal with regard to point No. 3 i.e. certified copy of jurisdiction map of Police Station Mauli Jagran.

In reply, CPIO/East submitted that requisite information was provided to the appellant.

So far as the appeal is concerned, CPIO/East has asserted that requisite information was furnished to the appellant; however, appellant is raising this appeal for obtaining certified copy of jurisdiction map of Police Station Mauli Jagran. The definition of "Right to information" defined under section 2 (j) (ii) of RTI Act categorically states as under:-

> "Right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to (ii) taking notes, extracts, or certified copies of documents or records;

Taking note of the above mentioned definition, CPIO/East is hereby directed to supply the certified copy of jurisdiction map of Police Station Mauli Jagran to the appellant as per RTI Act.

With these observations, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
