ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 180/UT/RTI/FAA/SSP dated 28.09.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on three points with regard to complaint no. 2019-09265 dated 23.05.2019 i.e. copies of action taken report, statements, report submitted by I/O etc.

Comments of CPIO/South :

CPIO/South submitted that RTI application of the appellant was received from CAPIO/PHQ vide letter No. 1829/RTI/CAPIO/PHQ/UT/PWS dated 03.09.2019 for supplying information on three points with regard to complaint no. 2019-09265 dated 23.05.2019 i.e. copies of action taken report, statements, report submitted by I/O etc. Thereafter, requisite information was obtained from SHO/PS-39 and the appellant was informed vide letter no. 561/CPIO/South dated 06.09.2019 that applicant is neither complainant nor alleged in the complaint. Moreover, he did not mention any relationship with the above said complaint, hence, disclosure of information has no relationship to any public interest and would cause un-warranted invasion of privacy of the individual. So, information was denied u/s 8(1)(j) of RTI act.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on three points with regard to complaint no. 2019-09265 dated 23.05.2019 i.e. copies of action taken report, statements, report submitted by I/O etc.


In reply, CPIO/South had denied the requisite information u/s 8(1)(j) of RTI act being a personal information.

So far as the appeal is concerned, CPIO/South submitted that appellant is neither complainant nor alleged in the complaint and he did not mention any relation with the complaint in question. Hence, the information was denied to the appellant.

However, in the interest of justice, CPIO/South is directed to contact the appellant telephonically on his given mobile number or through other means and asked for authority letter or any other document in his favour for getting requisite information. In case, appellant submit the same, proceed accordingly as per RTI act.

With these observations, the instant appeal stands disposed of accordingly.


In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
