ORDER

The appellant has preferred her 1st appeal dated 16.10.2019 against the reply/order of CPIO/W&CSU with regard to point no. 02 of her RTI application dated 17.09.2019 with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 187/UT/RTI/FAA/SSP dated 16.10.2019 for further proceeding under RTI Act.

Information sought vide RTI application :

The appellant had sought information on 04 points pertaining to complaint no. 2017-18310 dated 20.12.2017 i.e. copies of proceedings of mediation Centre, summons, receipt of speed post and proceedings of counselling etc.

Comments of CPIO/W&CSU :

CPIO/W&CSU submitted that RTI application of the appellant was received in his/her office on 17.09.2019 for supplying information on 04 points pertaining to complaint no. 2017-18310 dated 20.12.2017 i.e. copies of proceedings of mediation Centre, summons, receipt of speed post and proceedings of counselling etc. Thereafter, requisite information was obtained from SHO PS WPS and the same (in pointwise form) was supplied to the appellant vide letter no. RTI-452/UT/DSP/W&CSU dated 11.10.2019. As far as the appeal is concerned, the same is filed specifically related to point no. 02 i.e. Photocopy of Receipt or summon dated 07.06.2018 to the accused Ashwani Kumar. In this connection, CPIO submitted that on 05.06.2018, an intimation call letter was issued to Ashwani Kumar and others for joining enquiry on 25.06.2018 at 11:00 AM. The same was served to Mr. Ashwani Kumar on 07.06.2018 and ready to be supplied to the appellant. Since the summon was

issued on 05.06.2018, not on 07.06.2019 as claimed by the appellant, hence, not supplied to him.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/W&CSU vis-à-vis material available on record which revealed that the appellant had sought information on 04 points pertaining to complaint no. 2017-18310 dated 20.12.2017 i.e. copies of proceedings of mediation Centre, summons, receipt of speed post and proceedings of counselling etc.

In reply, CPIO/W&CSU had supplied the requisite information in pointwise form except information of point no. 02.

So far as the appeal is concerned, the same is filed specifically related to point no. 02 i.e. photocopy of Receipt or summon dated 07.06.2018 to the accused Ashwani Kumar. In this connection, CPIO submitted that on 05.06.2018, an intimation call letter was issued to Ashwani Kumar and others for joining enquiry on 25.06.2018 at 11:00 AM. The same was served to Mr. Ashwani Kumar on 07.06.2018. Since, the summon was issued on 05.06.2018, not on 07.06.2019 as claimed by the appellant, hence, not supplied to him at the time of disposal of RTI application. The same is available in the office of CPIO/W&CSU.

In view of above, CPIO/W&CSU is hereby directed to supply the copy of aforementioned summon to the appellant as per RTI act.

With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
