**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 194/UT/RTI/FAA/SSP dated 25.10.2019 for further proceeding under RTI Act.

**Information sought vide RTI application :**

The appellant had sought information on two (02) points with regard to complaint no. 2019-10468 dated 11.06.2019 i.e. Copies of Intimation Call Letters issued by SI Dharamvir Singh and his statements etc.

**Comments of CPIO/South :**

CPIO/South submitted that RTI application of the appellant was received through registered post on 07.09.2019 for seeking information on two (02) points with regard to complaint no. 2019-10468 dated 11.06.2019. Thereafter, requisite information was obtained from SHO PS Sector 34 and the appellant was informed vide letter no. 576/CPIO/South dated 07.10.2019 that the complaint bearing no. 2019-10468 dated 11.06.2019 is under enquiry, hence, requisite information could not be supplied to him and denied u/s 8(1)(h) of RTI act. As far as the appeal is concerned, the above said complaint has been sent to senior officers for further proceedings after completion of enquiry.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on two (02) points with regard to complaint no. 2019-10468 dated 11.06.2019 i.e. Copies of Intimation Call Letters issued by SI Dharamvir Singh and his statements etc.


In reply, CPIO/South had denied the requisite information u/s 8(1)(h) of RTI act as the aforesaid complaint was under enquiry at that stage.

As far as the present status of the complaint in question is concerned, the same is still under enquiry in final stages.

In view of above, CPIO/South is hereby directed to supply the requisite information to the appellant as per RTI act as and when enquiry is completed.

With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
