ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 15/UT/RTI/FAA/SSP dated 03.03.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought certified copy of dossier form of accused Baljit Chaudhary s/o Chaman in case FIR No. 05/2020 u/s 307 IPC, section 25 of Arms Act 1959, PS-34, Chandigarh and list of others cases register against him.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that application of the appellant was received for supplying requisite information and report from SHO/PS-34 was obtained, thereafter, vide letter No. 55/CPIO/South dated 24.02.2021, requisite information was denied u/s 8(1)(j) of RTI Act being a third party.

Moreover, appellant has not shown any relation/interest with the matter. As far as appeal is concerned, appellant sought information for his defense in CBI case which is under trial in Special court of CBI, therefore, the same may be provided to the appellant.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought certified copy of dossier form of accused Baljit Chaudhary s/o Chaman in case FIR No. 05/2020 u/s 307 IPC, section 25 of Arms Act 1959, PS-34, Chandigarh and list of others cases register against him.

Insofar appeal is concerned, CPIO South is now ready to supply the requisite information, hence, instant appeal is hereby disposed of with the direction to CPIO South to furnish the requisite information to appellant forthwith as per the provisions of RTI Act.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
