ORDER

The appellant has preferred his 1st appeal through online RTI portal bearing No. PODEP/A/2019/60081 dated 01.11.2019 against the reply/order of CPIO/East in connection with his online RTI application bearing No. PODEP/R/2019/50618 dated 09.09.2019 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 199/UT/RTI/FAA/SSP dated 01.11.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 03 points with regard to his complaint i.e. copy of complaint, opinion of MC, Chandigarh and DDR No. 4.

Comments of CPIO/East

CPIO/East submitted that RTI application of the appellant was received through online RTI portal for supplying of requisite information. Thereafter, report from SHO/PS-Manimajra was obtained and accordingly information containing 8 pages was supplied to the appellant. As far as appeal is concerned, the appellant has raised the plea with regard to point

No. 2 i.e. copy of verification report of vendor fee which is also obtained from SHO/PS-MM and ready to supply.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought information on 03 points with regard to his complaint i.e. copy of complaint, opinion of MC, Chandigarh and DDR No. 4.

In reply, CPIO/East submitted that requisite information has already been supplied. As far as appeal is concerned, information on point No. 2 is ready to supply.

Since CPIO is ready to supply the requisite information with regard to point No. 2 i.e. verification report of MC, Chandigarh about street vendor fee receipt submitted by Amt Saxena. Hence, CPIO/East is hereby directed to supply the same to the appellant, as per RTI Act.

With these observations, the instant appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
