ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 16/UT/RTI/FAA/SSP dated 03.03.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought copy of action taken report with respect to complaint No. 2019-11522, 2019-13474, 2020-01298.

COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that application of the appellant was received for supplying requisite information and report from I/C HAC Branch was obtained, thereafter, requisite information containing 30 pages was supplied to the appellant vide letter No. 55/CPIO/Hqrs/RTI-2021, D-148 dated 12.03.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought copy of action taken report with respect to complaint No. 2019-11522, 2019-13474, 2020-01298.

Insofar appeal is concerned, CPIO PHQ has submitted that requisite information was supplied to the appellant but on the other hand, appellant has contended that no information was supplied to him. Hence, CPIO PHQ is hereby directed to confirm from the appellant whether he has received the requisite information or otherwise, if yet he does not receive the information, then furnish the requisite information forthwith to him. Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
