ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 207/UT/RTI/FAA/SSP dated 27.11.2019 for further proceeding under RTI Act.

Information sought vide RTI application :-

The appellant had sought information on 8 points pertaining to DDR No. 26 dated 05.11.2014, Name & Belt no. of official registering the said DDR, Attendance register of October & November, 2014 & duty roster of 05.11.2014 of all police officials of PS Sector 34 etc.

Comments of CPIO/South :-

CPIO/South reported that RTI application of the appellant was received in his office from CAPIO/PHQ vide letter no. 2034/RTI/CAPIO/PHQ/UT/PWS dated 03.10.2019 for seeking information on 8 points pertaining to DDR No. 26 dated 05.11.2014, Name & Belt no. of official registering the said DDR, Attendance register of October & November, 2014 & duty roster of 05.11.2014 of all police officials of PS Sector 34 etc. Thereafter, report of SHO PS Sector 34, was obtained. After which copy of DDR no. 26 dated 05.11.2014 and the name of official registering the said DDR i.e. HC Kartar Singh, No. 809/CP were supplied to the appellant. Rest of the information was denied u/s 8(1)(j) of RTI act, being personal information vide letter no. 639/CPIO/South dated 18.10.2019.

Decision :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on 8 points pertaining to DDR No. 26 dated 05.11.2014, Name


& Belt no. of official registering the said DDR, Attendance register of October & November, 2014 & duty roster of 05.11.2014 of all police officials of PS Sector 34 etc.

In reply, CPIO/South had supplied the copy of DDR no. 26 dated 05.11.2014 and the name of official registering the said DDR i.e. HC Kartar Singh, No. 809/CP to the appellant. Rest of the information was denied u/s 8(1)(j) of RTI act, being personal information.

Moreover, contents of RTI application were scrutinized which revealed that appellant had sought some personal information of other visitors/complainants of Police Station Sector 34 which was not primarily related to him. He had sought information according to his suitability/visualization which is not covered under the purview of RTI act e.g. copies of all documents, reports etc. written by lady officials having her names started with "H" during the months of October, November and December, copies of all documents written by MHC, AMHC etc alongwith their names, specimen signatures, Belt Nos. etc. from 03.11.2014 to 07.11.2014 etc. Information primarily related to the appellant has already been supplied to him.

In view of above, CPIO/South had rightly denied the information u/s 8(1)(j) of RTI act. With these observations, the instant appeal stands disposed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
