#### ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/East in connection with her RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 18/UT/RTI/FAA/SSP dated 17.02.2020 for further proceeding under RTI Act.

## Information sought vide RTI application:

The appellant had sought copy of his complaint given in PS-19 & action taken report upon his complaint along with copy of statements etc.

### Transfer of RTI Appeal:-

The instant appeal is also transferred to FAA-cum-SP/HQ vide letter No. D-56/RTI/FAA/SSP dated 28.02.2020 as the RTI application was dealt by CPIO/Communication.

## Comments of CPIO/East

CPIO/East submitted that RTI application of the appellant was received from CPIO/Communication for supplying the information. Thereafter, requisite information was obtained from SHO/PS-19 & 26 and requisite information containing 13 pages was provided to the appellant vide letter No. 52-RTI/CPIO/East dated 07.02.2020.

#### Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East & South vis-à-vis material available on record which revealed that the appellant sought copy of his complaint given in PS-19 & action taken report along with copy of statements etc.

In reply, CPIO/East had supplied information containing 13 pages to the appellant as per RTI Act. As far as complaint given to Const. Varinder Singh is concerned, CPIO/East submitted that no such complaint is found to be received in record.

Insofar instant appeal is concerned; information containing 13 pages has already been supplied to the appellant. However, CPIO/East is hereby directed to examine his record thoroughly once again and supply the remaining information to the appellant, if any, as per RTI Act.

It is pertinent to mention here that as per record of Public Window, a complaint bearing No. 202001024 of the appellant is still under enquiry with SHO/PS-19 and cannot be supplied at this stage. The same is denied u/s 8(1)(h) of RTI Act.

With these observations, as far as this office is concerned, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
