**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 211/UT/RTI/FAA/SSP dated 02.12.2019 for further proceeding under RTI Act.

**Information sought vide RTI application : -**

The appellant had sought information on 4 points about arrest of Proclaimed Offender Mr. Prakash Chand declared in case No. NACT/0001021/2015 i.e. copy of court order etc.

**Comments of CPIO/Central:-**

CPIO/Central reported that RTI application of the appellant was received in his office from CPIO/Hqrs. vide letter No. 1526/DSP/Hqrs/RTI-19/D-1552 dated 30.10.2019 for supplying the requisite information. Thereafter, requisite information was obtained from I/C PO & Summon Staff and the same was sent to the applicant on his given address. As far as appeal has concerned, on PO Prakash Chand has been arrested and produced before the Hon'ble Court. It is pertinent to mention here that

appellant is now satisfied with action of concerned police officials and he appreciated the same by email dated 11.12.2019.


**Decision :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 4 points about Proclaimed Offender Mr. Prakash Chand declared in case No. NACT/0001021/2015 i.e. copy of court order and other issues in questionable form.

In reply, CPIO/Central supplied the requisite information to the appellant.

Insofar the instant appeal is concerned; it is clear from email of the appellant that he is quite satisfied with arrest of PO Parkash Chand by police officials of PO & Summon Staff. Hence, no more action is warranted in the instant appeal, accordingly, the same is hereby filed.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
