ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 14/UT/RTI/FAA/SSP dated 01.02.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought enquiry report of her complaint bearing No. 2018-18339.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that application of the appellant was received for supplying requisite information and report from SHO/PS-34 was obtained, thereafter, appellant was informed vide letter No. 90A & 90B/CPIO/South dated 12.02.2021 that complaint in question i.e. 2018-18339 is consigned with HAC branch after enquiry.

PERSONAL HEARING

Appellant has sought personal hearing before deciding her appeal. In this regard, personal hearing was scheduled on 24.03.2021 but she did not attend the personal hearing. Subsequently, another personal hearing was scheduled for 30.03.2021 but she intimated her disability to attend personal hearing due to the persisting corona virus situation. Hence, her appeal is entertained by undersigned on merit basis.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought enquiry report of her complaint bearing No. 2018-18339.

Insofar appeal is concerned, it is clear that complaint in question i.e. PW No. 2018-18339 is consigned with HAC Branch and CPIO/South has informed the appellant only about the status of her complaint and did not furnish the requisite documents/information. Hence, CPIO/South is hereby directed to furnish the requisite information to the appellant, after obtaining from the concerned branch. Accordingly, instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
